- 5- Meter room of size 10x10x10 ft. for L.T. Connection. With independent gate entry from outside of premises is to be constructed by you.
- 6- It shall be consumer responsibility to obtain Row/way leave permission or Road Cutting Permission from Concerned Department. The actual amount for the same has to be deposited by the Consumer.
